Council Meeting June 23, 2025

The Maysville Board of Aldermen met in regular session on Monday, June 23, 2025 at 6:00 pm pursuant to the Missouri Sunshine Law 610.021.

Mayor Ronnie Pearl called the meeting to order with the following members present: Clint Sollars, Darrell Conley, Amy Justus and Larry Zieber.

Also present were City Clerk Pat Fisher-Johnson, Jennifer Justus, Diana and Gerald Estes, Tony Purcell, Casey Flinn, Gary Carter and Michele Allwood.

The meeting was called to order and Mayor Pearl led us in the pledge followed by a prayer from Alderman Zieber.

Alderman Zieber made a motion to approve the consent agenda. Seconded by Alderman Sollars. Motion carried. This included minutes of the June 12,2025 meeting and the following checks: Water 6927-6931, Wastewater 3526-3530, Street 4461-4464, General 22039-22043, Park 1236, and Payroll 10938-10948.

Diana was present to discuss the nuisance ordinance and why it takes so long to process the issues. The entire process of the handling of nuisance violations was explained to her.

Gary was present to discuss if an alley behind his house has ever been closed. Clerks have looked for the closed alley ordinance and were not able to find one. Michele stated there is a sewer main that runs in the alley therefore, we need to have access to the line. Board voted to leave it as it but allow people to use it as they have been but we have to have access to it.

Casey was here to visit about contracts and stated he was preparing one for the board to review.

Michele reported she is in the process of obtaining the lead and copper samples, working on the DNR order and answered the DNR letter for our sewer inspection.

Jennifer gave a brief report.

Clint reported for city crew: mowing, cut a tree down at Bartlett Park, installed 3 light poles at the park, worked with Michele on the sewer report, the city crew attended a Dig-Rite locate class, and the repair man fixed the JD tractor.

Alderman Sollars made a motion to go into closed session to discuss an employee review. Seconded by Alderman Zieber. Roll call: Justus -yes, Sollars – yes, Conley – yes and Zieber – yes. Motion carried.

Alderman Justus made a motion to go into open session. Seconded by Alderman Conley. Roll call vote: Justus – yes, Conely – yes, Zieber – yes and Sollars – yes. Motion carried.

Alderman Justus made a motion to give Tony Purcell a \$2.00 increase in salary effective June 30. Seconded by Alderman Conley. Motion carried.

Alderman Sollars made a motion to put Ordinance # 2025-18 on its first reading by title only, "AN ORDINANCE REVISING THE TOTAL FUND ACCOUNT IN THE 2024-25 FISCAL YEAR BUDGET FOR THE CITY OF MAYSVILLE, MISSOURI". Seconded by Alderman Justus. Roll call vote: Justus – yes, Sollars – yes, Zieber – yes and Conley – yes. Motion carried.

Alderman Zieber made a motion to put Ordinance # 2025-18 on its second and final reading by title only, "AN ORDINANCE REVISING THE TOTAL FUND ACCOUNT IN THE 2024-25 FISCAL YEAR BUDGET FOR THE CITY OF MAYSVILLE, MISSOURI." Seconded by Alderman Conley. Roll call vote: Justus – yes, Conley – yes, Sollars – yes and Zieber – yes. Motion carried.

Alderman Zieber made a motion to put Ordinance # 2025-19 on its first reading by title only, "AN ORIDINACE ESTABLISHING THE ANNUAL BUDGET FOR THE CITY OF MAYSVILLE, MISSOURI FOR THE FISCAL YEAR 2025-2026." Seconded by Alderman Justus. Roll call vote: Sollars – yes, Justus – yes, Conley – yes and Zieber – yes. Motion carried.

Alderman Sollars made a motion to put Ordinance # 2025-19 on its second and final reading by title only, "AN ORDINANCE ESTABLISHING THE ANNUAL BUDGET FOR THE CITY OF MAYSVILLE, MISSOURI FOR THE FISCAL YEAR 2025-2026."

Seconded by Alderman Conley. Roll call vote: Alderman Zieber – yes, Conley -yes, Justus – yes and Sollars – yes. Motion carried.

The board agreed to allow fireworks from June 27th to July 6th until 10:00 pm.

With no further business, Alderman Conley made a motion to adjourn. Seconded by Alderman Justus. Motion carried.

The meeting was adjourned at 8:20 pm.
