Maysville Board of Aldermen August 5, 2024

The Maysville Board of Aldermen met in regular session on Monday, August 5, 2024 at 6:00 p.m. in open session pursuant to the Missouri Sunshine Law 610.021.

Mayor Ronnie Pearl called the meeting to order at 6:00 pm with the following board members present: Peggy Harwood, Larry Zieber, Clint Sollars and Amy Justus.

Also present were: Tyler Zimmerman, Robert Walser, TH Bosler and Pat Fisher Johnson.

Mayor Pearl opened the meeting with the pledge and Alderman Zieber said the prayer.

Alderman Sollars made a motion to approve the consent agenda, minutes of the July 22, 2024 minutes and the following checks: Water ck# 6664-6675, Wastewater ck# 3371-3380, Street ck# 4303-4308, General ck# 21792-21806, SW ck# 1613 and Payroll ck# 10483-105707. Seconded by Alderman Harwood. Motion carried.

City Clerk asked about the two laborers attending a class for streets in October. Board approved this training.

The board then had their tax levy hearing for 2024. This year's tax levy will be \$1.4056. Alderman Justus made a motion to put ordinance #2024-10 on its first reading by title only, "AN ORDINANCE LEVYING TAX UPON ALL PROPERTY TAXABLE IN THE CITY OF MAYSVILLE, MISSOURI FOR THE YEAR 2024, AND FIXING THE RATE THEREOF". Seconded by Alderman Harwood. Roll call vote: Justus – yes, Sollars – yes, Zieber – yes and Harwood – yes. Motion carried.

Alderman Sollars made a motion to put Ordinance #2024-10 on its second reading by title only, "AN ORDINANCE LEVYING TAX UPON ALL PROPERTY TAXABLE IN THE CITY OF MAYSVILLE, MISSOURI FOR THE YEAR 2024, AND FIXING THE RATE THEREOF". Seconded by Alderman Zieber. Roll call vote: Harwood – yes, Justus – yes, Sollars – yes and Zieber – yes. Motion carried.

The board reviewed the bids for our new HVAC units for City Hall. These bids were tabled until next meeting.

Alderman Harwood made a motion to go into closed session for legal issues. Seconded by Alderman Sollars. Roll call vote: Sollars – yes, Justus – yes, Harwood – yes and Zieber yes. Motion carried.

Alderman Justus made a motion to reenter into open session. Seconded by Alderman Larry. Roll call vote: Zieber – yes, Justus – yes, Sollars – yes and Harwood – yes. Motion carried.

Alderman Justus made a motion to purchase 10 archery targets @110 each. These targets will last up to 10 years if treated properly. Seconded by Alderman Zieber. Motion carried.

There was discussion about cameras and lighting at the battliste. Furh.

The contractor will be pouring walls for the new street shed next week.

There was discussion about purchasing a box blade grader with teeth on the front of it (land grader). The board agreed to spend up to \$8000 but no more.

Alderman Harwood then made a motion to sell the grader to Foley's. Seconded by Alderman Justus. Motion carried.

Other equipment was discussed but tabled until future meetings.

Alderman Justus made a motion to put a bid in on the M & G Property when it goes up for delinquent tax sale at the courthouse with a max bid. Seconded by Alderman Sollars. Motion carried.

With no further business the meeting was adjourned at 8:30 pm.
