Maysville Board of Aldermen July 8, 2024

The Maysville Board of Aldermen met in regular session on Monday, July 8, 2024 at 6:00 p.m. in open session pursuant to the Missouri Sunshine Law 610.021.

Mayor Ronnie Pearl called the meeting to order at 6:00 pm with the following board members present: Peggy Harwood, Larry Zieber, Clint Sollars and Amy Justus.

Also present were: Jennifer Justus, Michele Allwood, Chris Heslinga, Mark Murphy and Pat Fisher Johnson.

Mayor Pearl opened the meeting with the pledge and Alderman Zieber said the prayer.

Alderman Sollars made a motion to approve the consent agenda, minutes of the June 24, 2024 meeting and the following checks: Water ck# 6640-6655, Wastewater ck# 3354-3334, Street ck# 4289-4297, General ck# 21768-21781, SW ck# 1612 and Payroll ck# 10439-10459. Seconded by Alderman Harwood. Motion carried.

There was discussion between council, Chris and Mark about the City sharing the cost to put concrete on the Hope & Victory Streets where the busses drive from the lobby entry door to the high school steps. Our Board took no action at this time due to pending meetings with MODot and waiting for their report detailing the drainage issues. Board of Alderman will attend the school board meeting in August to discuss the projects.

Jennifer reported she is sending out numerous letters to residents about mowing and weed eating.

Michele stated the crew has been working on a list of items from this morning's staff meeting. They are needing to change locks on everything so there is one key instead of multiple keys on the ring.

Michele stated they were planning to drain the 2nd mixing basin on Thursday and back wash the filter soon.

There was discussion about the summer help and making sure they are willing to work the 20 hours a week, or replacing with someone that does want to work 20 hours.

Board asked if the weeds around the square and down the bricks on Sloan Street can be sprayed.

Michele reported that the GIS mapping has been completed and she will get the information onto the computer once the new computer is delivered to the water plant.

The board then opened bids for gutters on the street shed. Alderman Sollars made a motion to award the bid to Hackett Contracting LLC for \$1200. Seconded by Alderman Justus. Motion carried.

Alderman Zieber made a motion to accept the financial statement to be published for January 1 to June 30, 2024. Seconded by Alderman Justus. Motion carried.

Alderman Zieber made a motion to sign the mutual aid agreement with MPUA. Seconded by Alderman Sollars, Motion carried.

The board will put the 50-cent tax levy for the next four years back on the April 2025 ballot for street improvements. Clerk will get the necessary paperwork ready.

Alderman Sollars stated he and William went to Milan to look at a road grader that was on Purple Wave. Alderman Sollars stated it was a 1990 where ours is a 1975. After discussion, Alderman Justus made a motion for City Clerk to set up an account so she can watch the bidding that ends on Tuesday the 16th so she can bid on it up to \$18,000. Seconded by Alderman Sollars. Motion carried.

Alderman Harwood made a motion to go into closed session. Seconded by Alderman Sollars. Motion carried.

Alderman Justus made a motion go back into open session. Seconded by Alderman Sollars. Motion carried.

With no further business the meeting was adjourned at 8:57 pm.
