Council Meeting November 10, 2025

The Maysville Board of Aldermen met in regular session on Monday, November 10, 2025 at 6:00 pm pursuant to the Missouri Sunshine Law 610.021.

Mayor Ronnie Pearl called the meeting to order with the following members present: Clint Sollars, Darrell Conley, Amy Justus and Larry Zieber.

Also present were City Clerk Pat Fisher-Johnson, Stephanie Ayres, Casey Flinn, Bruce, Annette and Randy Gibson, Michelle and Jason Coffman and TH Bosler.

The meeting was called to order and Mayor Pearl led us in the pledge followed by a prayer from Alderman Zieber.

Alderman Justus made a motion to approve the consent agenda. Seconded by Alderman Conley. Motion carried. This included minutes of the October 27, 2025 meeting and the following checks: Water 7058-7064, Wastewater 3592-3599, Street 4543-4555, General 22138-22150, Pk 1257, SW 1578-1579 and Payroll 11140-11161.

The Coffman's were present to discuss their water bill with the board. Board will review the bill and advise them of their decision. After reviewing, Alderman Justus made a motion to take the 6-month average and bill them for that usage. Seconded by Alderman Sollars. Motion carried.

The Gibson's were present to discuss the trees that were cut down by their logger on City property. The Gibson have been attempting to make contact with their logger but unable to make contact with him. The council stated they would like to work this out without having to proceed with legal action. Attorney advised to continue with action and if contact is made then we will work from there. Our attorney will send a letter to the Gibson's logger and see if he will respond.

Alderman Sollars made a motion to go into closed session to discuss legal issues. Seconded by Alderman Justus. Roll call vote: Sollars -yes, Justus - yes, Conley - yes and Zieber - yes. Motion carried.

Alderman Zieber made a motion to go into open session. Seconded by Alderman Justus. Roll call vote: Sollars -yes, Justus – yes, Conley – yes, and Zieber – yes. Motion carried.

Stephanie was given the new contract that DNR is wanting from F/S. Stephanie said she would give it to Casey to review and get it back to TH. Casey later joined the meeting and asked a few questions prior to signing.

Other discussion was held as we are getting closer to the connection with the Great NW Wholesale Water line. City Clerk will get more details when they have their zoom meeting on Thursday.

Alderman Sollars gave a report from the crew: fixed area by the courthouse where bricks were popping up, have used a pallet of patching, installed the items for the dog park, winterized bathroom at Barlett Park, cameras are installed at Bartlett Park, and working on replacement of meters.

The board agreed to expend open burning until end of November.

City Clerk will check on our holiday dinner and get it scheduled.

Alderman Justus stated she would like to get a Holiday Decoration to put up at the water plant – the price for the decoration is \$1476. This was budgeted so board approved it.

Alderman Justus made a motion to approve the health insurance quote with the 13.9 percent increase. Seconded by Alderman Sollar. Motion carried.

Board agreed on longevity payments that will be given at the holiday dinner.

With no further business, Alderman Zieber made a motion to adjourn. Seconded by Alderman Conley. Motion carried. The meeting was adjourned at 8:41 pm and the next meeting will be November 24th at 6:00 pm.
