Maysville Board of Aldermen October 9, 2024

The Maysville Board of Aldermen met in regular session on Wednesday, October 9, 2024, at 6:00 p.m. in open session pursuant to the Missouri Sunshine Law 610.021.

Mayor Ronnie Pearl called the meeting to order at 6:00 pm with the following board members present: Peggy Harwood, Amy Justus, Larry Zieber and Clint Sollars.

Also present were: Michele Allwood, Jennifer Justus and Pat Fisher Johnson.

Mayor Pearl opened the meeting with the pledge and Alderman Zieber said the prayer.

Alderman Justus made a motion to approve the consent agenda, minutes of the September 25, 2024 minutes and the following checks: Water ck# 6719-6731, Wastewater ck# 3407-3412, Street ck# 4338-4345, General ck# 21846-21854, Solid Waste ck#1615 and Payroll ck# 10585-10605. Seconded by Alderman Zieber. Motion carried.

Jennifer reported during the Good Neighbor Cleanup Campaign, there were volunteers that helped out several locations within the town. We appreciate the efforts of the volunteers.

Fall clean up will be October 26th from 8 am to Noon at the water plant. Residents must take items to the water plant to be put in the dumpster. Scrap metal will also be picked up curbside at residences.

Jennifer said she has ordered the 2025 dog tags.

Michele reported she is still working with different departments to try to figure out why our water turbidity keeps spiking. She has borrowed a machine to test for manganese and iron. Michele reported that she would have an engineer here to see about changing chemicals.

The Clerk asked if the crew could get hazard light bars for all of the trucks at a cost of less than \$50 per vehicle. Board agreed to purchase them.

Alderman Sollars made a motion to make a donation of \$500 to North Central Missouri Business Facilitation. Seconded by Alderman Justus. Motion carried.

Alderman Zieber reported that he has ordered 8 – 15-foot poles to place the lights on for Bartlett Park. The poles will be painted black.

The board reviewed the quote for street repairs from Approved Paving. After discussion, the board would like to get a new quote for the following: Ausman Drive, Jackson Street, Macadee, and to start at South Water Street and go as far as our money will allow up Hull & Taylor Street.

Alderman Justus made a motion to proceed and spend up to \$34,650 with the additional gravel for the top of Jackson. Seconded by Alderman Harwood. Motion carried.

The board agreed to leave board meetings on Wednesday nights until Spring.

The Mayor asked that the city crew look at Railroad Street and check the culvert signs that needs to be addressed.

Alderman Sollars made a motion to hire F/S Excavating to repair the drainage issues on Elm & South Water Street. Seconded by Alderman Harwood. Motion carried.

The crew will look at the handicap access ramps on the corners of South Washington & Hwy 6 and Independent Farmers Bank.

The Board agreed to close City Hall at 3:00 on Halloween for the Trick 'er Truck event on the square. Alderman Harwood, Jennifer and Pat will hand out candy.

Alderman Justus made a motion to fix the final lift station at the lagoons. The estimate is for \$10,892.00. Seconded by Alderman Zieber. Motion carried.

The city gave water to approximately 132 households during the Saturday drop and the Tuesday evening drop. The city employees will continue to hand out water as customers ask.

City Clerk was given permission to proceed with her AMGI for a 2nd phase of the Certified Municipal League from MML.

City Clerk was asked to contact Andy with Synder & Associates to come to the next meeting to discuss the water plant connection.

Alderman Justus made a motion to go into closed session to discuss personnel. Seconded by Alderman Sollars. Roll call vote: Harwood – yes, Sollars – yes, Justus – yes and Zieber - yes. Motion carried.

Alderman Harwood made a motion to go into open session. Seconded by Alderman Sollars. Roll call vote: Harwood – yes, Sollars – yes, Zieber - yes and Justus – yes.

With no further business the meeting was adjourned at 7:38 pm.
