## Maysville Board of Aldermen September 11, 2024

The Maysville Board of Aldermen met in regular session on Wednesday, September 11, 2024, 2024 at 6:00 p.m. in open session pursuant to the Missouri Sunshine Law 610.021.

Mayor Ronnie Pearl called the meeting to order at 6:00 pm with the following board members present: Peggy Harwood, Larry Zieber, Amy Justus and Clint Sollars.

Also present were: Donnie Rhoad, Ron McElwain, Jennifer Justus and Pat Fisher Johnson.

Mayor Pearl opened the meeting with the pledge and Alderman Harwood said the prayer.

Alderman Harwood made a motion to approve the consent agenda, minutes of the August 26, 2024 minutes and the following checks: Water ck# 6691-6705, Wastewater ck# 3389-3398, Street ck# 4321-4329, General ck# 21821-21831, SW ck31614, Park ck#1217-1219 and Payroll ck# 10539-10567. Seconded by Alderman Zieber. Motion carried.

Donnie was present to ask about getting his street paved, it was torn up 9 years ago and the dust is out of control. Board stated they are meeting with an asphalt company at the next meeting to work out a 5-year plan.

Ron was present to ask questions about the water boil order situation. Michele answered his questions and hopes with all the companies she and others have been talking it to will help get the situation back to normal.

Michele reported the towers and clear well have all been cleaned and are in good shape with no issues.

City Clerk stated the lights were in for Barlett Park now we just need the poles to get them installed. Alderman Zieber is talking with Daniel Colhour about getting them made.

City Clerk asked about the door that was purchased for City Hall but never installed. Clerk stated she has someone interested in in – board said to sell it.

There was discussion about the police car – the city crew will be asked to jump it and the mileage off it and see what we can get it out of it.

Alderman Sollars stated we should be getting our check for the sale of the maintainer for \$12,500.

Alderman Sollars made a motion to purchase an ad in the school year book for \$100. Seconded by Alderman Zieber. Motion carried.

The board agreed to pay the additional \$3000 for the updates to the City windows.

There was discussion about the locks and cameras at Barlett Park. There is a dead tree that will need to removed and the EZ Electric is working with Ameren to get the power to the park.

Alderman Harwood would like to do a monthly Honor A Veteran on the back of the sign for Bartlett Park.

Clerk will order the signs for the Farmer's market from Amazon.

Alderman Justus gave a report about the Christmas lighting around the square. Clerk will get ahold of EZ Electric to get an updated bid on the power to the poles.

The street crew is to get the salters in for repairs before we need them.

Alderman Harwood made a motion to go into closed session. Seconded by Alderman Sollars. Roll call vote: Harwood – yes, Sollars – yes, Zieber – yes and Justus – yes. Motion carried.

Alderman Zieber made a motion to go back into open session. Seconded by Alderman Justus. Roll call vote: Justus – yes, Sollars – yes, Zieber – yes and Harwood – yes. Motion carried.

Alderman Sollars stated that Travis LeMunyon has 15 blocks of concrete he would like to sell for \$1000. Alderman Sollars made a motion to purchase these to use at for the park and street projects. Seconded by Alderman Harwood. Motion carried.

Alderman Sollars reported that the archery range grant was not approved.

Clerk is to send the personnel policy to our attorney for review.

Once the bathroom, sign and shelter house are completed at Bartlett Park – the City would like to have an open house.

With no further business the meeting was adjourned at 9:00 pm.
